REGULATED MEDICAL WASTE • WASTE ACCEPTANCE POLICY

ACCEPTED WASTE:

•SHARPS – Any object contaminated by pathogens or that may become contaminated by pathogens through the handling or during transportation and are also capable of cutting, puncturing or causing abrasions to the skin or packaging material. Sharps consist of syringes, needles, culture slides, broken glass, rigid broken plastic, scalpels, culture dishes, broken capillary tubes and exposed dental wires.

•REGULATED MEDICAL WASTE – Any waste or reusable material derived from the medical treatment of humans, which includes diagnosis, immunizations, biomedical research that includes production and testing of biological products, including the medical treatment of animals.

ACCEPTED WASTE WHICH MUST BE IDENTIFIED AND SEGREGATED FOR INCENERATION

•TRACE-CHEMOTHERAPY WASTE – RCRA Empty drug vials, syringes and needles, spill kits, IV tubing and bags, contaminated gloves and gowns or any related materials as defined by state laws, applicable to the rules and regulations or guidelines.

•PATHOLOGICAL WASTE – Human or animal body parts, organs, tissues and surgical specimen (decanted of formaldehyde, formalin or other preservative).

•Non RCRA Pharmaceuticals (Non-Hazardous Pharmaceuticals) – Shall be certified and characterized as non-RCRA hazardous material by the generator. Consult Total Med Transportation representative for specific requirements. (832) 380-9159

WASTE (RMW) NOT ACCEPTED BY TOTAL MED TRANSPORTATION

- **Compressed Gas Cylinders, Canisters, Inhalers and Aerosol Cans**
- **Any Mercury Materials or Mercury Containing Devices**
- **Mercury-Containing Dental Waste**
- **Untreated Category A Infectious Substances**
- **RCRA Hazardous Pharmaceutical Waste**
- **Bulk Chemotherapy Waste**
- **Complete Human Remains**
- **Chemicals – Formaldehyde, Formalin, acids, alcohol, waste oil, solvents, reagents, fixer, developer**
- **Hazardous Waste – Drums or containers with a hazard warning symbol, batteries or other heavy metals**
- **Radio Active Waste – Materials with lead. Containers with radioactivity levels exceeding regulatory or permitted limits.**

Please note that additional waste acceptance policies may apply, based on state (TCEQ) requirements.
